Committee Reports

- **TREASURY:** Janet 3 handouts to review: The Jan. 2020 bank reconciliation, which Fran did; the actual 2019 budget results; and the proposed 2020 budget. After everyone had an opportunity to review Judy asked what would happen if \$ was allotted and not used (ex. Newcomer marathon) Janet said that at the end of year we would compare actual to projected numbers and update for the following year. This year, the money could be re-allocated somewhere else.
- Lorraine asked that the budget clearly reflect that the number is to send 2 reps not 4 to Region 7 conference. Janet made a motion to accept budget. Lorraine seconded. All were in favor.
- **OASIS**: **MaryAnn-** Spring Oasis will be in the mail March 21st. March 1st is the deadline for submissions. Anyone is welcome to submit an article, writing, etc...

Since the budget is \$300 Janet suggested to look at all 2020, Met Life, street fairs and see how they can all fit in within the \$300 budgeted amount. Judy suggested to spread it out as well (Met Life and Fair Lawn street fair would be within 2 weeks of each other in June)

Old Business

- Secretary Minutes whether or not to read at each meeting: Theresa motioned to not read the minutes at each meeting, but to email them out ahead of time and just come with questions/comments. Judy seconded. 1 abstained from voting, everyone else in favor.

New Business:

- **Open Positions –** Theresa nominated Frank for acting Vice Chair, Lorraine seconded. All were in favor. Judy nominated Janet for acting Treasurer, Shari seconded; all in favor
- Damaged Literature: Susan announced World Service keeps it around; contact if interested
- Non-profit incorporation: Susan: We don't have to pay sales tax in NJ; this incorporation also protects the Board Members from liabilities.
- Insurance review: Susan: Do not need new board insurance, we have enough.
- Intergroup communication ideas: Susan There are 34 meetings in our intergroup and we want to keep them. informed. Val will handle emailing intergroup communications to the reps, including minutes, calendars agendas and other relevant information. The by-laws will be emailed out shortly. It was asked if there were any suggestions on how to increase intergroup involvement. Susan suggested reaching out to the contact people from meetings where there is no presence at intergroup; perhaps someone can call them once a month? Susan L suggested to attend some meetings that are not represented and encourage them to come. No further action taken.
- Proposed replacement by-laws: Susan: Committee was formed with our trustee and re-wrote the by-laws. Updated 2014 by-laws to
 conform with World Service. People should read over the by-laws when they get them from Val and come next month prepared with any
 questions

- Oasis budget: Susan/Mary Ann the budget for 2019 was \$3200 and we have to cut it to \$1,000. New for 2019 was that we went to color, went to 4 sides and mailed out to intergroup. Lorraine motion to take away color printing and reduce the amount of mailings, but keeping the Oasis to 4 sides. Ann Marie second, majority in favor.
- Procedure Manual: Susan: Jen is working on a manual detailing how to start a meeting how to add something to the Oasis, etc
- To be discussed next month phone meetings on Oasis with meetings: vote meetings to allocate money towards Oasis.
