**Standing Committee Reports**

**Treasury:** Ilene stated transactions were pretty straight forward for the month of August; there were no extraneous expenses and income was on target thanks to the meeting donations.

**Oasis:** Mary Ann reported the new Oasis, There Is a Solution, will be coming out in the middle of this month. There will be four pages and a separate sheet containing a list of in-person and on-line meetings. Copies of the Oasis are sent either individually to members email addresses or as free paper copies mailed to the contacts for the 16 in-person meetings. There will be a place on the NJIOA website for individual members to request either free paper copies through the regular mail or PDF copies through email by emailing their name and mailing/email address to: [oasis@njioa.org](mailto:oasis@njioa.org).

**Public Information:** Terry P reported that the next NJ Psychological Association conference will be held on Saturday, October 17 in Livingston. Volunteers are needed to man the OA information table for a four-hour period. The service would involve answering questions from people visiting the table; there will be World Service literature written for professionals available as handouts.

**Sponsor Coordinator:** Jeff introduced Rena who has assumed the role of coordinator for the intergroup. He expressed thanks for Polly's wonderful service as the previous coordinator. Information from the recent Sponsorship workshop will be forwarded to Rena as it will include helpful information regarding sponsors and people looking for sponsors.

**Website:** Susan reported the website is doing great; new information is on the navigation bar; no corrections have been received and the speed of access has improved. **Literature/Scholarship:** Susan reported she mailed out 2 books to members. She asked the members to remind their groups that the books are free, the Big Book and the OA 12&12, for anyone wanting one.

**Events:** Judy mentioned the upcoming monthly events: September 28, Keeping the Peace, a Traditions workshop with 6 speakers, each covering 2 Traditions and their importance; October 5, Dr Bob and Bill W, 2 speakers on what you can learn from our founders' stories; an in-person Firelight meeting October 18, at Lorrimer Sanctuary, Franklin Lakes; November 21, I.D.E.A Day an international day of experiencing abstinence workshop sponsored by the 3 NJ intergroups; December 12, 12<sup>th</sup> Step Within, possibly sponsored by the Friday night HOW meeting.

Judy read the flyer that was distributed requesting stories of how the Fellowship helped during difficulties, relapses or life crises. It is a reaching-in request to support those members already here who may be struggling or ones not seen at meetings for a while. To date she has not received any responses. Fran made a suggestion to use the We Care list developed from the winter retreat as an additional mailing list for the monthly event flyers, maybe a month or two weeks before each event. Judy noted that she does often put the NJIOA events on the World Service calendar.
